Mr. Ragnar Alstrom is a lifelong Yukon River subsistence salmon fisherman and a Yukon River Limited Entry Salmon Permit holder since the inception of the Alaska Limited Entry Program. He is the Director of the Yukon Delta Fisheries Development Association and currently sits on the U.S. Section of the Yukon River Panel. Mr. Alstrom is a former member of the Council.

Mr. Paul Gronholdt has been a commercial fisherman since 1980 and owns the fishing vessel St. Francis. He is on the Board of Directors of the Southwest Alaska Municipal Conference.

Dear Mr. Rauch:

Please accept the following names, in priority order, as my nominees for one of the two obligatory Washington State seats to the North Pacific Fishery Management Council (NPFMC). Mr. Kenny Down currently occupies this seat; he was appointed to it in 2015 to fill out the unexpired term of Mr. John Henderschedt. Consequently, he is eligible for reappointment.

Washington State has consulted with a broad range of commercial, recreational, and public constituents in seeking nominations; the consultation list is attached. Particular efforts were made to recruit qualified women and minority candidates. In conjunction with the Washington Department of Fish and Wildlife, we have evaluated each candidate's suitability and qualifications relative to the Magnuson Stevens Act and the 2017 Guidance Document, and have also determined that none of them are federally registered lobbyists. Based on my evaluations of each candidate's qualifications, I am recommending the following individuals in priority order:

### 1) Mr. Kenny Down:

Mr. Down is the President and CEO of Blue North Fisheries, and has served on the Council since 2015. Prior to joining Blue North in 2012, he served as the Executive Director of the Freezer Longline Coalition, where he was a leader in the development of national policy supporting low impact fishing efforts, minimizing harmful effects of commercial fishing and supporting efforts at rational management of the fisheries. Mr. Down is a sitting board member of the Freezer Longline Coalition and the Alaska Longline Cod Commission, and has served on advisory boards of the North Pacific Fishery Management Council, including the Steller Sea Lion Mitigation Committee. Mr. Down resides in Seattle, Washington.

## 2) Mr. David Little:

Mr. Little is the President of Clipper Seafoods Ltd., a freezer longline company he founded in 1987 with six vessels operating in the Bering Sea. He currently serves as the President of the Freezer Longline Conservation Cooperative, a group of fourteen freezer

longline companies based in Washington and Alaska, and has served on several advisory boards, including the North Pacific Fisheries Management Council, the Stellar Sea Lion Mitigation Committee, and the Distant Waters Advisory Group. Mr. Little resides in Seattle, Washington.

#### 3) Mr. John Crowley:

Mr. Crowley is the Owner of the F/V Kristiana, a 69-foot vessel operating out of the Fishermen's Terminal in Seattle. He has owned and operated longline and salmon boats continuously since 1969. Mr. Little serves as an industry advisor on the North Pacific Fishery Management Council and as a trustee on the Fishing Vessel Owners Association. In addition, he has served on many other panels and boards, including the Ground Fish Advisory Panel – Pacific Council, the West Council Marine Fund Board of Directors, and the United Marine Fund Board of Directors. Mr. Crowley resides in Seattle, Washington.

While Mr. Down is my preferred candidate, I believe that each of these three candidates are well qualified to serve on the NPFMC and will support management values that promote resource conservation, habitat protection, and sustainable fisheries.
