Adjusted Bluefin, Northern Albacore, Swordfish Quotas

Adjusts the 2019 baseline quotas based on available (i.e., allowable) underharvest of the 2018 adjusted U.S. quotas

The final 2019 adjusted quotas are:

- Northern albacore 790.5 metric tons (mt) whole weight (ww)
- North Atlantic swordfish 3,378.2 mt dressed weight (dw)
- South Atlantic swordfish 75.1 mt dw
- Atlantic bluefin tuna Reserve category 225.3 mt ww



Amendment 5b Litigation - Dusky sharks

- April 2017 Amendment 5b final rule published
- May 2017 Oceana filed lawsuit regarding Amendment 5b
- March 2019 Court issues opinion and in April remands to Agency to:
 - "...consider all relevant data related to dusky shark bycatch in the HMS and non-HMS fisheries..." and
 - Submit a document to the Court by August 2, 2019 setting forth this consideration and addressing several points related to the approach taken in Amendment 5b
- August 2019 Agency filed document with the court. Document is available online at: https://www.fisheries.noaa.gov/action/amendment-5b-2006-consolidated-hms-fishery-management-plan-atlantic-shark-management



SEFSC Technical Memos for Protected Resources

- SEFSC Technical Memorandum-580 distributed at Safe Handling, Release and Identification workshops has been replaced by Technical Memorandum-735 (Careful Release Protocols) and Technical Memorandum-738 (Design Standards)
- All previously-approved release gears are still approved
- NMFS intends to initiate a rulemaking to codify the minor changes



PLL BFT Area Based & Weak Hook Management Measures

- Comments on proposed rule & DEIS by September 30, 2019
- Submit comments at <u>www.regulations.gov</u>, search docket "NOAA-NMFS-2018-0035"
- 4 public hearings (Gloucester MA, Houma LA, Toms River NJ, Manteo NC);
 2 conference calls / webinars (July 19 & July 31)
- Request for additional public hearing in Gloucester MA September 19, 2019
- NMFS has received comments opposed / in favor of most preferred alternatives, and additional suggestions for consideration



Individual Bluefin Quota (IBQ) – 3 Year Review

Final Three-Year Review of the Individual Bluefin Quota Program - completion by end of September

Final document

- No substantive changes to conclusions or recommendations contained in the Draft Three-Year Review (draft version released 5/10/19 and available here: https://www.fisheries.noaa.gov/webdam/download/90876562)
- Addition of some 2018 data (bluefin landings & dead discards, fishing effort)

MRIP and LPS Updates

MRIP fully transitioned to new Fishing Effort Survey

 New catch estimates and time series being used for management and stock assessments including the assessments for Gulf (2018) and Atlantic (2019) Blacktip Sharks

LPS Redesign updates

- Team is analyzing historical data to assess impacts of untested assumptions and deviations from probability sampling
- Assessing tournament impacts and "off frame" fishing effort for HMS
- Consultants from Colorado State and Westat are assessing novel methods to improve sampling efficiency and statistical validity
- Initial pilot study planned for 2020 to test modification to the LPIS



ESA Updates

- Consultation ongoing now for all HMS fisheries; will include all species listed recently (e.g., Bryde's whale; Oceanic whitetip shark, Giant manta ray)
- On August 1, 2019, Agency was sued by Defenders of Wildlife and Center for Biological Diversity for failure to complete consultation under the ESA on oceanic whitetip shark and giant manta ray

Shark Specifications

- Proposed rule to be published on September XX, 2019 (84 FR XXXX)
- Proposed to open all shark management groups on January 1, 2019
- Proposed quota changes:
 - Western Gulf of Mexico (wGOM) Blacktip: 358.9 mt dw (792,161 lb dw) up from 255.8 mt dw (563,799 lb dw)
 - o Eastern GOM Blacktip (eGOM): 39.0 mt dw (86,066.7 lb dw) up from 27.7 mt dw (61,256 lb dw)
- Final LCS retention limits for Directed Permit Holders: e+wGOM = 45. Atl = 25.
- Requesting comments on:
 - Increase in e+wGOM to 55, and increase to higher than 25 in Atl.
 - In Atl: consider adjusting to a higher percentage for LCS quota harvested.
- Comments due by October XX, 2019
- Written comments, "NOAA-NMFS-2019-0091", submitted electronically via the Federal eRulemaking Portal http://www.regulations.gov, or sent by fax or mail.



NMFS also adjusted the 2018 quota to account for underharvest of the 2017 adjusted U.S. NALB quota, within ICCAT limits (additional 131.75 mt).





Recreational Swordfish Landings







Tournament Updates





Previous AP suggestions

- SWO increase incidental retention limit (*under consideration*)
- Pursue research in closed areas (<u>under consideration</u>)
- Require modified hooks in Atlantic <u>under consideration as part of PLL Take</u> <u>Reduction Plan</u>
- Caribbean increase SWO retention limit & allow shark retention with Caribbean Small Boat Permit - <u>under consideration</u>
- Remove Gear Restricted Areas not needed due to IBQs <u>under consideration in</u> <u>Area-Based Management & Weak Hook scoping</u>



HMS Permit Endorsements

- Two new HMS permit endorsements became effective at the beginning of 2018
 - HMS Recreational Shark Endorsement (Jan-Aug 2019)
 - Allows for the retention of legal sharks caught in the recreational fisheries
 - 15,167 issued to 26,552 qualifying permit holders (57%)
 - 11,288 HMS Angling, 2,656 HMS Charter/Headboat; 1,223 Tuna and/or Swordfish General (for tournament fishing only)
 - HMS Charter/Headboat permit commercial sales endorsement (2019)
 - Allows the commercial sale of HMS caught by HMS charter/headboats, provided certain conditions are met
 - In Jan-Aug 2019, 3,615 HMS Charter/Headboat permits were issued; 1,475 of those have the endorsement (41%)
