NOMINATION CANDIDATES OBLIGATORY SEAT CARIBBEAN FISHERY MANAGEMENT COUNCIL

Dear Mr. Oliver:

I am pleased to submit my recommendations for the Caribbean Fishery Management Council (CFMC) obligatory seat that will become vacant on August 10, 2020. As part of our efforts in the recommendation process, we conducted various calls and consulted the recreational sport fishing community, including the Puerto Rico Recreational Fishing Association, several yacht clubs, the Fisheries Advisory Board and leaders from the commercial fishing sector. Enclosed you will find the list of consulted persons in the commercial and recreational fishing community.

In accordance with the *Magnuson-Stevens Fishery Conservation and Management Act*, the recommendation of candidates to be submitted for the consideration of the Secretary of Commerce are the following:

1. Capt. Marcos Hanke Classification: Recreational sector. Mr. Hanke is in his second term as the Puerto Rico representative of the recreational sector in the CFMC, and he is the current President of the Council. He also represents the marine recreational sector in the Fisheries Advisory Board of the Puerto Rico Department of Natural and Environmental Resources (DNER) and is a charter operator. Besides, Mr. Hanke represents Puerto Rico in the NOAA's Advisory



Board of "Highly Migratory Species" and has developed initiatives to conserve fishery resources, educational efforts and multiple works with fishers. He is a contributor to the current effort promoted by NOAA and the DNER to create an Education Program for Recreational Fishers. When DNER consulted about the referenced vacant seat with the two Puerto Rico representatives of the commercial fishers in the CFMC, they both recommended him as their top candidate. One of the people consulted, recognized the excellent qualifications of all identified candidates, but made particular emphasis on Mr. Hanke's performance and achievements in the Council: "His outstanding participation in the CFMC speaks for itself. He has extensive knowledge in all types of fishing and fisheries management. I attest that he is a conciliatory entity and is always open to listen to suggestions and harmonize with all sectors. He is definitely a valuable resource for all fisheries sectors." The other Puerto Rico member of the Council we consulted expressed the following: "I consider him a person very open to communication and to maintain an environment of respect and cordiality, besides that I have had the opportunity to evaluate his direct performance at the CFMC and I consider that his nomination must continue for the benefit and continuity of the projects. He has done a great job and has all my support and of the commercial sector." In summary, both current CFMC members praised Hanke's knowledge and leadership, and his ability to foster effective communication through constructive dialogues and respect among all the members of the Council. DNER's representative in the Council can attest that Mr, Hanke possesses these skills. The President of the Fishers Federation and the commercial fishers of the southwest of Puerto Rico recommend Mr. Hanke for the seat. Moreover, DNER received a letter from the Yacht Club of San Juan supporting Mr. Hanke for another term.

2. Attorney Israel Umpierre- Classification: Recreational sector. He is a recreational fisherman, has participated in CFMC meetings, specifically in the "District Advisory Board", leads the non-profit organization "Fishing, Beach and Environment" and as such has carried out educational and outreach activities, including the importance of sharks and beach cleaning campaigns. He has contributed to the work of the Puerto Rico Fisheries Advisory Board. Furthermore, Mr. Umpierrre contributes to current efforts promoted by NOAA and the DNER, to create an Education Program for Recreational Fishermen. He has shown interest in the vacant seat and completed the required documentation.

- 3. Capt. Roberto Reyes Classification: Recreational sector. He is a recreational fisherman, "free-diver" and has participated in meetings of the Fisheries Council, especially in the "District Advisory Board". Furthermore, he represents the marine recreational sector in the Fisheries Advisory Board. Capt. Reyes has contributed to the DNER, being a key volunteer in the educational campaign for the consumption and control of lionfish at the SOFO culinary festival held a few years ago. He contributes to current efforts promoted by NOAA and the DNER, to create an Education Program for Recreational Fishermen.
- 4. Mr. Luis M. Lagrandier Classification: Recreational sector. He is a recreational fisherman and a leader in the sport sector. Mr. Lagrandier is chair of the Sportfishing Association of Dorado (Municipality of Dorado) and a member of the Board of Directors (Secretary) of the Puerto Rico Recreational Fishing Association. He has promoted the importance of conserving our fisheries and other natural resources. Furthermore, he encourages compliance with fishing season closures and restricted fishing areas. He has participated in Mahi-mahi tagging programs and attended a MRIP meeting in Puerto Rico last year. He contacted the DNER expressing his interest in joining the CFMC.

As part of the consultation process to identify qualified candidates for the PR obligatory seat, DNER welcomed any interested individual, including qualified women and minority candidates. In this process we contacted the Chair of the Puerto Rico Recreational Fishing Association, who is a woman. She helped us distribute the announcement of the vacancy among the members of the Association. Unfortunately, we did not receive applications from woman interested in occupying the vacant seat.

However, after announcing the vacancy and after consulting with representatives of the recreational and commercial fishing community of Puerto Rico, we are pleased with the identified candidates. All nominees are by experience or training, knowledgeable regarding the conservation, management, and recreational harvest of the fishery resources of Puerto Rico. Furthermore, the identified nominees have backgrounds and personal characteristics that would contribute to achieving diversity in Council membership. The first three nominees have collaborated with DNER with enthusiasm in conservation efforts in the past.



On the other hand, DNER has ensured that nominees understand that a Council appointment is for a three-year term and that they are willing and able, to make the commitment to fully participate in Council business and related activities for the duration of the term.

Due to his attributes, performance and support from both the recreational and commercial sectors, we have identified Mr. Marcos Hanke as our preferred nominee.
