
In order for this exemption to be effective, NMFS, Alaska Region must receive a complete Part II - Inseason Notice of Exemption (Inseason Notice) at least one day prior to the date on which the applicants want the exemption to take effect. The Inseason Notice must be submitted as a single package with a completed, signed, and dated application signed by at least one IFQ Permit Holder, one IPQ Permit Holder and one Community Representative that are the subject of the exemption contract.



If an Inseason Notice is submitted by mail, the effective date of the exemption is the day after NMFS receives a complete Inseason Notice.
