## Dear Reviewer:

In accordance with provisions of the National Environmental Policy Act (NEPA), I enclose for your review the *Draft Environmental Impact Statement (DEIS) for Issuing Annual Catch Limits to the Alaska Eskimo Whaling Commission for a Subsistence Hunt on Bowhead Whales for the Years 2019 and Beyond.* 

This DEIS was prepared pursuant to NEPA to assess the environmental impacts associated with NOAA's issuance of annual catch limits for a bowhead whale subsistence hunt by the Alaska Eskimo Whaling Commission (AEWC). The International Whaling Commission will conduct its next meeting in September 2018 in Florianopolis, Brazil, and based on the management advice of the IWC Scientific Committee, is likely to adopt a catch limit for 2019 through 2024 or 2025 at the same or similar levels as the current catch limits. The purpose of this action is twofold: to manage the conservation and sustainable subsistence utilization of the Western Arctic stock of bowhead whales (as required under the ICRW, the WCA, the MMPA, and other applicable laws) and to fulfill the Federal Government's trust responsibility to recognize the cultural and subsistence needs of Alaska Natives.
