

## Research Track Working Group Questionnaire Instructions (v. 1/16/2020)

The Research Track is a formal scientific process used in the Northeast Region for detailed evaluation and analysis of fishery science research topics that are related to stock assessments and assessment models. Research Track Working Groups (WGs) carry out analyses that are then peer reviewed by an independent review panel. Approaches that are approved by the peer review panel are then typically implemented in stock assessments in a subsequent Management Track (A full description of this new process is located [here](#)). These stock assessments form the scientific basis for managing fish and invertebrate marine resources in US waters of the northwest Atlantic.

### Upcoming Research Track WGs

Following guidelines developed by the Northeast Regional Coordinating Committee (NRCC), the Northeast Fisheries Science Center (NEFSC) is currently seeking Research Track WG applicants for **Evaluating Index-Based Methods and Control Rules**.

### Selection Process

Recently, the NRCC developed guidelines on WG formation in the SAW/SARC process (see below) and those same guidelines are currently being used to guide formation of Research Track WGs. As part of this selection process, all candidates for Working Groups, other than the WG Chair and Lead Stock Assessment Scientist, are required to submit a completed questionnaire, on which the Overall Chair of the Process and the Research Track WG Chair will base their initial set of recommendations. A spot on the WG is available for the Council and/or Board staff representative with responsibility for the stock or topic. This representative should still complete and submit the questionnaire. The list of all applicants, as well as these initial recommendations, will then be provided to a higher-level decision committee composed of Deputies or their representatives from each of the five NRCC organizations: NMFS NEFSC, NMFS GARFO, MAFMC, NEFMC and ASMFC. This decision committee will make a final decision regarding approval of the membership of each candidate.

### Selection Criteria

Criteria to be considered by the decision committee will include independence, expertise, and education of candidates, as well as Research Track WG size, composition and balance. Effective workgroups typically consist of 4-8 members with a broad range of skills and proficiency and should include individuals from several disciplines. Applicant qualifications should be directly relevant to the particular stock or topic under consideration.\*

Short list selected for SAW WG by (target date): February 14, 2020

All questionnaires and short list delivered to NRCC Decision Committee (target date): February 21, 2020

NRCC decisions due to NEFSC (target date): February 28, 2020

Public Announcement of Decisions (target date): March 6, 2020
