General Takeaways

- Sustained engagement with rec. community has improved dialogue
- Remaining challenges are complex & difficult to address
- Improved opportunity is desired
- Greater collaboration, transparency, & understanding is needed



Innovative Management

- Recognition that many innovative approaches are possible under existing law
- Fishermen, councils, and NOAA need to collaborate to move innovative management forward.
- Substantial enthusiasm for finding appropriate fisheries to pilot novel/innovative management
- Acceptance of an iterative approach



Socio-Economics

- Perspective: better data, more analyses, and greater consideration in management will improve rec. opportunity
- Calls to provide the Councils with "needed socioeconomic information"
- Public input into the NMFS' prioritization and planning, including the socioeconomic strategic plan, is desired



Data Collection and Reporting

- Data was a central discussion point raised by constituents in every session—catch, effort, socioeconomic.
- Perspective: more, better, and more timely catch/effort data will lead to more fishing opportunity
- Recreational electronic catch & effort reporting seen as the future, but challenges were recognized
- Interest in advancing ER with private angler ER pilot program(s) outside the Gulf



Conservation

- Foster additional habitat and forage fish conservation
- Innovative gears have a roll to play to improve rec. fish conservation and fishing opportunity
- Reducing recreational discard mortality remains a priority



Engagement and Building Trust

Increased engagement & communication is needed to increase trust. Suggested actions to increase trust included:

- Greater participation / transparency in priority setting & planning
- More collaborative research and greater involvement in research design
- Improve angler confidence in data
- Enhance fishing opportunity
- Expand understanding of the science and management process (MREP)
